

## Higher Education Emergency Relief Fund Report – Emergency Financial Aid Grants to Students

May 13, 2020

**West Coast Ultrasound Institute (OPE ID: 036393)** received education stabilization funds under Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”), Public Law No: 116-136. This Fund Report applies to the student portion received under the Higher Education Emergency Relief Fund that is designated exclusively for emergency financial aid grants to students.

The institution appreciates that Congress and the President have made these critical funds available for eligible students who have expenses related to the disruption of campus operations due to the coronavirus pandemic. We take receipt of these federal funds seriously and are distributing them in accordance with the CARES Act and implementing guidance.

1. The institution signed and returned to the Department the Certification and Agreement [for] Emergency Financial Aid Grants to Students. The institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide emergency financial aid grants to students.
2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution’s Certification and Agreement [for] Emergency Financial Aid Grants to Students is **\$902,941.00**.
3. The total amount of emergency financial aid grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of this Fund Report is **\$767,500.00**.
4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, and thus eligible to receive emergency financial aid grants under Section 18004(a)(1) of the CARES Act, as of the date of this Fund Report is **1,229**.
5. The total number of students who have received an emergency financial aid grant under Section 18004(a)(1) of the CARES Act as of the date of this Fund Report is **1,229**.
6. The methods used by the institution to determine which students receive emergency financial aid grants and how much they would receive under Section 18004(a)(1) of the CARES Act are provided at **Attachment A**.
7. Any instructions, directions, or guidance provided by the institution to students concerning the emergency financial aid grants are provided at **Attachment B**.

## Attachment A

WCUI has established a HEERF Fund to make emergency grants immediately available to eligible students. *To be eligible, a Student must be (as of Friday 4/29/2020):*

- *Actively enrolled at WCUI;*
- *In good academic and financial standing;*
  - *Must be in good financial standing: Student is eligible if has only missed payments for current term. Student is not eligible if has missed payments before current term.*
  - *WCUI has 3 levels of SAP compliance*
    - *Warning (least severe): Students are eligible*
    - *Probation: Students are eligible*
    - *Provisional: Students are NOT eligible and ;*
- *Title IV eligible (under Section 484 in Title IV of the Higher Education Act of 1965). Students who have not yet filed a FAFSA, but meet Title IV eligibility criteria, are also eligible.*

### **HEERF Student Fund (1<sup>st</sup> Half of HEERF):**

- Total: \$902,941
- First Disbursement (85% of fund): \$767,500
- Second Disbursement (15% of fund): \$135,441

### **Disbursement Policy for HEERF Student Fund**

- **First Disbursement:** WCUI will distribute 85% of the fund equally to all eligible students. This formula will be  $\$767,500 / \# \text{ of eligible students}$ . In order to receive these funds, Students must sign WCUI's HEERF Certification.
  - Final Numbers Round 1
    - Round 1: 1,229 Students
    - $767,500 / 1,229 = \$624.49$
    - Rounded to \$625 per student
    - Total Round 1:  $\$625 * 1,229 = \$768,125$  (85.069%)
    - Round 2 Availability: \$134,816
- **Second Disbursement:** WCUI will retain 15% of these funds for future student emergencies related to COVID-19 on a as-needed basis. Eligible students will need to apply for these funds. In order to receive these funds, Students must apply using WCUI's HEERF Application Form. WCUI will consider the following factors in making decisions:
  - Financially responsibility for:
    - food expenses
    - housing expenses
    - expenses related to my course materials to attend school
    - expenses related to technologies associated with attending online classes
    - health care costs
    - childcare expenses
  - Exceptional Need due to COVID-19:
    - Students will be able to write in for an additional fund request based on the above parameters. Not all students will be selected.
- **Third Disbursement:** If there are any funds still available in the fund as of 4/28/2021—after the Second Disbursement—WCUI will distribute all of the remaining funds in equal installments to all eligible Students (same Eligibility Requirements as First Disbursement).

## **Attachment B**

The following instructions, directions, or guidance provided by the institution to students concerning the emergency financial aid grants:

- Student acknowledges that the HEERF grant funds provided by WCUI to Student are for use by Student for expenses related to the disruption of campus operations due to coronavirus, including any eligible expenses under a student's cost of attendance, such as food, housing, course materials, technology, health care, and childcare and other expenses.
- Student acknowledges that WCUI is required by Section 18004(e) of the CARES Act to report to the Secretary regarding how grants were distributed to students, the amount of each grant awarded to each student and how the amount of each grant was calculated.
- Student certifies that he/she is a U.S. citizen or eligible non-citizen; has a valid Social Security number; has registered with Selective Service (if applicable); has a high valid school diploma or its equivalent; and is not in default on a Title IV loan.
